



## TERMS AND CONDITIONS

### GENERAL

- Dance Majic is committed to our Child Safety policy, found on our website - [www.dancemajic.com](http://www.dancemajic.com)
- Students under the age of 18 years are not to leave the premises at any time.

- No bullying of any kind will be tolerated by Dance Majic.

### UNIFORM

- Uniforms are compulsory and can be purchased at the studio.
- Whilst wearing licensed Dance Majic uniform students are a representative of the studio and should behave accordingly as not to present the studio in a negative light.

### FEES AND PAYMENT

- A **non-refundable fee** of \$49 is payable upon enrolment for all students to secure their place.
- Term class fee payments are to be paid in full by week one of that term. Class fees can be paid by cash or direct bank transfer (term fee invoice number and student name for reference eg. 001 Jane Smith).

- Fees that are late may incur a late payment fee.
- Two weeks' notice in writing is required for any child leaving the studio. No refund will be given for classes not attended or for any remaining classes in the instance a student leaves prior to the end of term when term payments are made.

### SHOWCASE

Our Showcase is an important event held mid November at Darebin Arts and Entertainment Centre, Preston. All students are expected to participate and will be invoiced a Production Levy fee:

- Our \$80 Ready Set Move Production Levy and \$150 Ready Set Dance Production Levy covers a viewing link of our Showcase, the hire, cleaning and maintenance of costumes, co-ordination and supervision of students throughout rehearsals and performance and venue hire for both rehearsal and performance days.
- Our \$80 Dance Majic Production Levy, for all other Dance Majic students, covers a viewing link of our Showcase, co-ordination and supervision of students throughout rehearsals and performance and venue hire for both rehearsal and performance days. This will be debited from your costume account. The Production Levy does NOT cover costumes, cleaning or maintenance. Costume fees will be charged separately. Production fees and levies are non-refundable.

### SOCIAL MEDIA

- By enrolling in Dance Majic, you consent to allowing photography and videography on Dance Majic's social media platforms. Any requests to not participate must be made to Derralie Coonan (Principal).
- All social media use will be appropriate, safe and in context. Pages are monitored heavily and foul behaviour will not be tolerated.
- Students with their own social media accounts are representing Dance Majic and should behave in such manner. Dance Majic strongly encourages parental guidance and monitoring of behaviours of both their child and other people on social media.
